

# Terms of Use

## Important Information

You should carefully read the following Terms and Conditions (also referred to as the “Terms of Use”, “Terms of Service” or “TOS”). Your use of our service(s) implies that you have read and accepted these Terms and Conditions. The Website, Outdoor Lighting Now, may hereafter be referred to, both individually and collectively, as “The Website”) from which you accessed this agreement is provided to you subject to the conditions listed below. These terms are in addition to any other terms that individual Website owners within the Outdoor Lighting Now may include for governing access to their Websites.

Any Non-Human Visitors to these Websites shall be considered agents of the individual(s) who controls, authors or otherwise makes use of them. Such individual(s) shall be deemed responsible for the actions of their Non-Human Visitor devices in the same manner as if they personally visited the Website.

The access rights granted to you under the Terms of Use are non-transferable without the express written permission of the owner of Outdoor Lighting Now. You are responsible for the actions of any other person who may utilize your access rights on the Outdoor Lighting Now Website.

## Introduction

The following terms and conditions govern all use of the Outdoor Lighting Now Website and all content, services, and products available at or through the Website. The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other associated operating rules and policies (including, without limitation, Outdoor Lighting Now Privacy Policy).

Please read this Agreement carefully before accessing or using the Outdoor Lighting Now Website. By accessing or using any part of the Website, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not access the Website or use any services. If these terms and conditions are considered an offer by the Outdoor Lighting Now Website acceptance is expressly limited to these terms.

The Website is available only to individuals who are at least 13 years old. If you are not yet 13 years old, you must stop using the Website immediately or else provide Outdoor Lighting Now with written parental approval.

## **Your Outdoor Lighting Now Account and Site.**
